This refers to Al-Ghoreiri & Partners Industrial division, letter ref. no. AG/bh/841 dated 4th May, 1998, and their respective letter addressed to you, ref. no. AG/bh/122 dated 1st March, 1998.

Having reviewed submitted documents and based on our actual experience (please note that this material has been already approved for touch - up painting of steel towers - Lot 9001) we have the pleasure to recommend use of this galvanising system for the MEW projects having in mind all the advantages already mentioned by the Supplier/Manufacturer.

However, we wish to point out only two of the advantages which we consider very important in a work practice:

- Easy application on the big size elements, which are not suitable for the standard type galvanising, like a crane beams etc.
- Due to non existence of the galvanising plant in Qatar, a possibility to perform the painting works, either in workshop or in situ, gives an advantage both in time and cost saving.

We hope this will help you to make a proper decision in this regard.
